



Partner Agreement

Yes, sign me up as a Partner with LetsGoGreen! I want to become an environmental crusader and help spread the word to groups and organizations about how they can raise funds for themselves, help their families, and support their community and the environment. I understand the program works as follows:

- I am an independent contractor and not an employee of LetsGoGreen.
- The fundraising groups that I sign up will receive 25% of all online product sales (excluding S&H) that are generated by them, based on the current pricing in effect at time of sale.
- There is no fee or up front costs to sign up as a fundraiser with LetsGoGreen.
- This is an on-going, year-round fundraising program.
- All orders are taken online at the LetsGoGreen.biz website.
- All products will be shipped by LetsGoGreen directly to the customer.
- All customer payments will be collected by LetsGoGreen through the website.
- Once I am activated in the LetsGoGreen system I will receive:
 - LetsGoGreen Partner Kit
 - LetsGoGreen personalized business cards (100)
 - LetsGoGreen personalized email address (Firstname.Lastname@LetsGoGreen.biz)
 - LetsGoGreen "Partner Success Manual"
 - A customized PDF Fundraiser Agreement Form that can be printed or emailed to potential fundraising groups
 - Access to additional LetsGoGreen marketing materials
- My commission will be 5% of all online product sales (excluding S&H) that are generated by fundraising groups that I sign up, based on the current pricing in effect at time of sale.
- I will receive a Form 1099 at the end of the year and I am responsible for paying taxes on my commissions.
- I will be given a login and password to the LetsGoGreen Partner Center that will allow me to view sales and commissions online and in real time.
- I will be paid monthly via check, within 7-10 business days following the close of the prior month.
- My success is dependent on the number of customers driven to the LetsGoGreen.biz website to purchase products in support of the fundraising groups that I sign up (designated at checkout).
- As an independent contractor with LetsGoGreen, I will run my business at all times in an honest and ethical manner and failure to do so will result in termination of this agreement.
- I understand that the LetsGoGreen name, logo, trademark and marketing materials may not be used in any unauthorized manner. Any new usage must be approved in writing by LetsGoGreen.
